

### Task Force "Ukraine"

#### **Context:**

Following the adoption of "UBC Resolution on Brutal and Unprovoked Russian Invasion of Ukraine" During the XVII UBC General Conference, taking place in Palanga, Lithuania, on 26 October 2023, the network decided to mandate UBC Antenna in Brussels to create a framework for the task force and operationalize the support to Ukrainian cities being associated members in the network.

In spring 2022, Vilnyansk became the first Ukrainian city to join the UBC, leading the way for other Ukrainian cities such as Kherson, Kramatorsk, Pokrovsk, Vyshhorod, Zaporizhzhia and Khmelnytskyi. to follow. At the same time UBC became an observer member of the platform: "European Alliance of Cities and Regions for the Reconstruction of Ukraine" in April 2024 in order to be more active in supporting Ukrainian cities in reconstruction and European integrations.

Among other statements in above mentioned resolution, UBC explicitly calls for:

- "for deeper integration of Ukraine into the European Union and providing Ukrainian local and regional authorities access to European networks";
- "Empowering local self-governance to play a more significant role in directing recovery and reconstruction efforts".

The task force "Ukraine" will aim to operationalize those two statements and provide a concrete framework for UBC Members Cities and Ukrainian Observer Cities to cooperate, exchange expertise and build long-term strategic alliances.

## The aim and roles of task force:

The main aim of the task force is to prepare the framework for the integration of new Ukrainian cities into the UBC activities and support them during the war, and post-war democratic consolidation and recovery.

The specific roles of this task force will be to:

- 1. Provide a framework for active participation of Ukrainian Observer Member Cities in a sustainable manner;
- 2. Develop the mutual benefits for the UBC Member Cities to access European funding reserved for cooperation with Ukraine, expand the cooperation with Ukrainian cities and for Ukrainian Associated Cities to reach EU standards in green policies and practices, social and democracy policies);

#### **Members:**

The members of the task force will be coming from the Member Cities, Executive Board, Board of Audit, Secretariat, Presidium, The coordinator for Ukraine, Commissions, and will be moderated by UBC Brussels Antenna.

#### **Activities:**

**Tandem programme:** UBC Tandem program focusing on bilateral policy cooperation between UBC Member Cities and Ukrainian Associated Member Cities in reaching EU standard in democracy and sustainable development;

**EU Funding support mechanism:** Creating and kicking-off an EU Funding project schemes on EU projects that develop and implement together, policy coordination (joint advocacy and policy influence mechanism);

**Participation within UBC:** Mainstreaming and reinforcing the active participation of Ukrainian cities through existing UBC Structure such as policy positions, participation in commissions, task forces and similar.
