During the last two years Task Force on Youth Employment and Well-Being has concentrated on three themes (STEAM, Basic Skills and Attractiveness of the VET) and arranged eight events (workshops, seminars, conferences and meetings) with over 200 participants. A need to continue cooperation within these issues (especially STEAM, but also Basic Skills) has become evident. Task Force on Youth Employment and Well-Being would like to propose a discussion about its future, including the TF new tasks and status (merging with Youthful Cities Commission or establishing a new commission). 5. Smile City project proposal, Rostock.

In September 2020 the City of Rostock was granted a huge financial support within the national programme SMART CITY made in Germany aimed to be a SMART model city for the wellbeing of its citizens. Rostock set up a special task force in order to concentrate strongly on this challenge which can use the allocated financial resources funding during seven years working under the brand SMILE CITY.



By the beginning of 2022 Rostock is planning to start a Baltic-wide debate on these themes and is inviting UBC to commonly develop this format and to make it accessible to all UBC member cities. More information about the project is attached.
