3. Proposal from Latvian member cities re amendments in the Statute.

In 2020 the TF intends to concentrate on three major themes as follows:

- STEAM (Science, Technology, Engineering, Arts, Math) Path for every child and youngster

- Basic Skills or Upgrading Pathways (youngsters with basic skills problems such as math, literacy, IT)
- Attractiveness of Vocational Education and Training

The Board accepted the proposal to continue the work of UBC Task Force on Youth Employment and Well-Being.

5. Introduction to Lahti European Green Capital 2021.

Saara Vauramo, Director, Lahti Green Capital 2021, informed that the City of Lahti was awarded the European Green Capital Award 2021 by the European Commission. Ms Vauramo presented activities and projects to be carried out in Lahti in 2021 within the frame of Lahti European Green Capital 2021. Presentation is attached.
