## **Information on the UBC Commission on Transportation - 2012**

1. Number of Member Cities participating in the meetings, projects and other work of the Commission. (List of member cities (including names of their key representatives) with short description of the participation activities)

The activity of the members of the Commission on Transportation is rather limited. We asked by e-mail 42 contact persons for the Commission on Transportation in the UBC member cities about their interest in further activities of our commission and sent them also the questionnaire on transport issues. There was a little response – 14 members of our Commission answered (Kuressaare, Tartu – Estonia; Rostock – Germany; Kotka – Finland; Klaipeda, Siauliai - Lithuania; Jurmala, Liepaja, Riga – Latvia; Gdynia, Pruszcz Gdański – Poland; Karlstad, Örebro, Växjo – Sweden)

The questionnaire was prepared on the basis of the EU document: "White Paper 2011. Roadmap to a Single European Transport Area - Towards a competitive and resource efficient transport system". The aim of the survey was to find out which topics gain most interest among the member cities.

The subjects of greatest interest resulting from the survey were:

- 1. Transport safety and security ("Vision zero" on road safety, cycling safety, pedestrian safety, safety in public transport)
- 2. Service quality and reliability (passengers with reduced mobility, multimodal journeys)
- 3. European transport research and innovation policy (clean, safe and silent vehicles, technologies to improve transport safety and security, parking policy, access restriction /limited car entrance to the city centre/, reducing the need for transport through city planning)
- 4. Promoting more sustainable behaviour (public transport, cycling, walking, co-modality including bike and ride)
- 5. Integrated urban mobility (integrated public transport development)
- 6. Transport infrastructure (multimodal urban transport development)

## • Commission on Transportation "Walk to School" Grant Competition 2012

In October 2012 the Commission on Transportation announced the "Walk to School Grant Competition" for primary schools or non-governmental organizations. The participants were to prepare a project/programme concerning promotion of walking on the way to school, the project is to be realizes within the school year 2012/2013.

The jury of the competition awarded projects which:

- introduced activities aimed at supporting, motivating and encouraging children and parents to walk to school,
- introduce healthy lifestyle into the daily routine of pupils,
- promote safe walking,

- promote sustainable urban mobility

Commission on Transportation received applications from 7 UBC Member Cities: Rakvere (Estonia), Voru (Estonia), Kemi (Finland), Chojnice (Poland), Gdynia (Poland), Kaliningrad (Russia) and Soederhamn (Sweden).
